Mishaps OR Near mishaps

- Report all mishaps to instructor
- <u>Mishap</u>
 - Any event that results in personnel injury or property damage, no matter how slight.
- <u>Near Mishap</u>
 - Any event that could result in personnel injury or property damage but is avoidable
- Unsafe condition
 - Situation, procedure that you believe could cause injury

SAFETY MISHAP INVESTIGATION



The Safety Officer will conduct a safety investigation of every Mishap whether deemed major or minor

The immediate supervisor or senior instructor present at the time of a training mishap will immediately notify the chain of command and initiate a safety investigation

Emergency Mishap Plan
